Artha India Ventures Closes First Half of INR 500 Cr Second Fund

Artha India Ventures (AIV), the family office of veteran investor Ashok Kumar Damani, has marked the first close of its INR 500 Cr (\$56 Mn) Artha Venture Fund II (AVF II) at INR 250 Cr (\$30 Mn). The fund also includes a green-shoe option of INR 100 Cr, allowing for potential expansion based on investor interest.

With AVF II, Artha plans to back 36 seed-stage startups across sectors including premium consumption, fintech infrastructure, applied AI, and deeptech. The fund will continue to follow Artha's 1–2–4 investment model, designed to provide strategic follow-on capital as portfolio companies scale.

smallest.ai Raises \$8 Mn Seed Round to Power Next-Gen Voice AI for Enterprises

Voice AI startup smallest.ai has secured **\$8 Mn in seed funding** to accelerate its mission of building enterprise-grade AI voice agents. The round was led by **Sierra Ventures**, with participation from 3one4 Capital, Better Capital, and other strategic investors.

Founded in 2023 by Sudarshan Kamath and Akshat Mandloi, smallest.ai is developing foundational AI models for text-to-speech and intelligent voice agents tailored for high-volume enterprise use.

The startup's Al-powered agents are already handling over 1 million calls for major clients across industries including debt collection, real estate, ecommerce, and logistics—demonstrating real-world traction at scale.

Viksit Bharat Buildathon 2025

Over 1 crore students from Classes 6 to 12 across India are set to participate in the Viksit Bharat Buildathon 2025, the country's largest school hackathon, aimed at fostering innovation and problem-solving at a young age.

Launched on September 23, 2025, by Hon'ble Education Minister Shri Dharmendra Pradhan, the event encourages students to develop prototypes aligned with themes such as Swadeshi, Atmanirbhar Bharat, Vocal for Local and Samriddh Bharat.

Key Dates & Program Timeline:

- Sept. 23, 2025: Official Launch
- Sept. 23 Oct. 11: Student registrations open on the official portal
- Oct. 11 Oct. 12: Team formation, mentoring, idea camps, and innovation circles
- Oct. 13, 2025: Nationwide Synchronised Live Buildathon live-streamed across all participating schools
- Oct. 13 Oct. 31: Entry submissions on the portal
- Nov. 1 Dec. 31: Evaluation by expert panel
- Jan. 2026: Felicitation of top-performing teams

Awards & Recognition: With a prize pool of ₹1 Crore, the Buildathon will recognize:

- 10 National-level winners
- 100 State-level winners
- 1,000 District-level winners
